### Conditions, Permit to Utilize Tribal Waters WP-EXAMPLE

- 1. The pumping rate from this well shall not exceed X gallons per minute for (PURPOSE OF USE).
- 2. The total annual use shall not exceed (QUANTITY) acre feet of water. (FOR IRRIGATION USE) In no case shall the application of water exceed one acre-foot of water per irrigated acre per year.
- 3. The total irrigated acres shall not exceed X acres defined as Tax Lot (#) may be watered by the domestic permit.
- 4. A flow and totalizing meter shall be maintained in proper working condition and shall remain accessible to representatives of the Tribal Department of Natural Resources for taking readings following reasonable notice.
- 5. This Permit to Utilize shall be in effect for a period of (#) years. At the end of the (#) years the permittee will be notified of the permit expiration and will be given the opportunity to renew the permit following the permit renewal procedures set forth in the Water Code of the Umatilla Indian Reservation.
