a) Public Hearing for Conditional Use file CU-24-002:

Applicant Ahsley Winn sought a Conditional Use approval from the Land Protection Planning Commission to construct a residence with well and septic in the Big Game Grazing Forest (G-1) zone on Umatilla County taxlot 1N340000-00118, located off Evergreen Lane near the Deadman's Pass Rest Stop area.

Holly Anderson presented the staff report along with Exhibits 1-4 detailing the proposal based on information provided by the Applicant.

Staff recommended approval with a condition requested by the CTUIR Wildlife Program Manager of prohibiting perimeter fencing around the property to avoid any impeding wildlife grazing and

migration.

Several attendees – including the Applicant - spoke in favor of the proposal. Koko Hufford, the CTUIR landowner gave neutral testimony. No attendees (0) spoke in opposition to the proposal. The Commissioners heard testimony that area ranchers actively grazed cows on the property, by using salt blocks, water and corrals to draw them into this area. They had not obtained any permission from the property owners to do this. They clarified that cattle guards had been removed from the property, the Commission agreed that the property owner should be able to place a fence at the perimeter if desired to fence cattle out and that wildlife would typically be able to jump any fences.

Motion: Travis Olsen moved to approve the Conditional Use without conditions. 2nd: Sam Spino. Passed 4-0-0.
