## b) Variance File #V-23-002:

Applicant Urban Patterns, LLC, on behalf of their client Carinspring Mills, LLC, sought approval from the Land Protection Planning Commission to construct a 65' flour mill tower. The subject property was identified as Lot 1 of the Coyote Business Park South Subdivision within trust parcel T2103-C, which is within the external boundaries of the Umatilla Indian Reservation. property is zoned I-D, Industrial Development, where structures other than grain elevators are limited to 45 feet in height.

Lora Elliott presented the staff report along with Exhibits 1-3 detailing the Applicant's proposal. She provided information on the subject property and detailed the Applicant's proposal for meeting the criteria to grant a variance approval.

Staff recommended approval of the proposal, provided the Applicant meet the following condition:
(1) The Applicant must complete a Cultural Resource Survey of the subject parcel and conform to findings from the resulting Cultural Resource Investigation.

Three (3) attendees – all representing the Applicant – provided information on the design of the facility and testimony in favor. No attendees provided neutral or oppositional testimony.

The Commission confirmed with Staff that they requested comments on the proposal from the Fire Department, though they did not receive any.
