Following final Board of Trustee approval (BOT Resolution), applicant shall submit the approved easement instrument along with the applicable recording fee to the Tribal Planning Office for recording in the Umatilla County Office of County Records. If the new easement right-of-way involves land held in trust by the BIA Indian Agency, the easement instrument shall be recorded following the BIA Indian Agency approval process.
