
Mission

Goals


- 1. Oversee the Department to ensure it operates efficiently and in compliance with tribal policies.
- 2. Supervise the Fire Chief, Police Chief, Family Violence Services Program Manager, Prosecutor and Child Support Enforcement Attorney-Manager.
- 3. Assist Legislative Coordinator and Public Affairs in development of legislative position on public safety issues including travel to Olympia, Salem, and Washington DC to work with the lobbyists and assisting them in legislative efforts.
- 4. Promote a cooperative relationship with adjoining public safety agencies to ensure the safety of members living on and off the reservation.

Mission and Goals, Tribal Fire Department

- Provide effective emergency services to the CTUIR community
 - 1. Provide twenty four hour life safety services
 - 2. Prevent loss of life and reduce property damage
 - 3. Recruit additional volunteers
 - 4. Maintain well trained and equipped department
 - 5. Conduct annual fire inspection
 - 6. Plan and implement three community activities
 - 7. Provide adequate financial resources



Area Resources

- The Umatilla Tribal Fire Department is currently staffed at 3 personnel a 48 hour shift, backed up by off duty staff and 8 volunteers. Wildland vehicle resources are 2

 type 6 (light brush) 1 type 4 (heavy brush)
- And 1 type 1 tender/pumper.
- BIA resources consist of 6 personnel, 3 type 6, 1 type 4, BIA is on 12 hour shift, on call off duty. BIA is patrolling the reservation 8 hours throughout day light hours. <u>BIA can request federal resources if need be.</u>
- Oregon Department of Forestry are staffed with 2 type 6 also 12 hour shifts, on call after hours.
- Air resources are currently grounded due to limited visibility.

Mutual Aid Agreements

- In the event UFTD and BIA resources are depleted or need additional resources, a request for <u>mutual aid from our neighboring departments</u>, if father resources are need UTFD is a member of a <u>Tri County Mutual Aid agreement with Umatilla</u>, <u>Moro and Gilliam counties</u>.
- The Tribes may request the governor to invoke a conflagration (ORS 476.510) through Umatilla County Fire Chief currently Scott Goff, Umatilla Co. Fire Dist. 1.


Mission and Goals

Mission and Goals, Office of Child Support Enforcement

Mission: Establish and enforce child support obligations for the benefit of children and families.

Goals:

- 1. Locate custodial and non-custodial parents and collect information about them such as address, assets and employment.
- 2. Offer voluntary paternity testing, negotiate acknowledgements of paternity, file affiliation cases and obtain judgments.
- 3. Obtain and modify support orders in Umatilla Tribal Court.
- 4. Garnish wages and assets of support obligors, distribute support to custodians of children, and provide the tribe, support payers, support receivers and grant administrators with accurate accounting of all payments and distributions.
- 5. Advise the Board of Trustees in the development of tribal policies regarding child support enforcement.
- 6. Manage and direct the Office of Child Support Enforcement.
- 7. Provide outreach and education to tribal members about the benefits of child support.

Mission and Goals, Family Violence Services

To provide CTUIR culturally appropriate support services to victims of domestic violence, sexual violence, elder abuse, teen dating and stalking.

- 1) Continue to promote awareness of domestic violence, sexual assault, and stalking
- 2) Track and monitor offenders
- 3) Increase safety for victims within surrounding nations by creating a network and collaboration. Strengthen tribal codes regarding family violence and sexual assault
- 4) Awareness of family violence through community and department education


