By submission of a quote the contractor agrees, if selected, to enter into a contract with the Confederated Tribes of the Umatilla Indian Reservation, Department of Natural Resources and to complete all work as specified in the proposal for the proposed costs and within the contract time frame indicated in this RFQ.

The quote must be arrived at independently and be prepared in accordance with the enclosed instructions. To assist in arriving at a quote price, all contractors are encouraged to participate in a site tour.

Contractors should be advised that, prior to award of any contract, the CTUIR Department of Natural Resources' Wildlife Program reserves the right to conduct a pre-award survey for the purpose of determining the contractor's responsibility and capacity to perform the contract. This survey may include review of prior subcontracting agreements, financial capacity, and quality of work performed on other contracts.

All quotes must be signed and dated; if a joint venture is submitting the quote, each joint venturer must sign the quote. All quotes must include Quote # **487-024/RFQ01**.

PROJECT DESCRIPTION AND LOCATION

The Confederated Tribes of the Umatilla Indian Reservation (CTUIR), Department of Natural Resources Wildlife Program is requesting quotes for construction of a security fence at the main check station parking area at 31440 Hwy 730 Umatilla Oregon, 97882. This site is approximately 1.5 miles east of the town of McNary, Oregon on the south side of Hwy 730.

SECURITY FENCE CONSTRUCTION

Scope of Work:

1) Construction of 6' chain-link perimeter fence with 3-strand barb-wire top extension. Fence dimensions are approximately 34 x 38 yards (144 yards total). Fence to include: 1) access gate for on-foot entry and 2) 2 vehicle gates to accommodate vehicle and trailer ingress and egress.

REQUIRED DOCUMENTS

The following documents must be included with the quote form:

1. Brief document or statement describing anticipated construction timeline and outline of resources available to the company to complete proposed work.
2. Brief company description (including personnel and resources) and list of **at least three** references for previous work of this type, or similar.

INDIAN PREFERENCE

Responsive and qualified Indian owned businesses, certified by the CTUIR's Tribal Employment Rights Office (TERO), will receive preference in the award of this contract according to the TERO Code.
