## 2024 COLUMBIA RIVER WINTER COMMERCIAL SETLINE FISHERY

Pursuant to Chapter 2 of the Fish and Wildlife Code of the Confederated Tribes of the Umatilla Indian Reservation, the Fish and Wildlife Commission has the authority to establish emergency regulations for Umatilla ceremonial, subsistence, and commercial fisheries. Pursuant to that authority, the Fish and Wildlife Commission adopted the following regulations.

## **Bonneville Pool and The Dalles Pool Closures**

**Area:** Bonneville Pool Closure

**Dates:** 6 PM Wednesday January 8, 2025.

Allowable Sales: Sturgeon from 38 to 54 inches in fork length in Bonneville Pool may be sold or kept for subsistence purposes. Fish landed during the open periods are allowed to be sold after the period concludes.

Area: The Dalles Pool Closure

Dates: 6 PM Saturday January 11, 2025.

Allowable Sales: Sturgeon from 43 to 54 inches in fork length in John Day Pool may be sold or kept for subsistence purposes. Fish landed during the open periods are allowed to be sold after the period concludes.

Area: John Day Pool Remains Open

Dates: January 1 through January 31, 2025 or until the guideline is reached.

Allowable Sales: Sturgeon from 43 to 54 inches in fork length in John Day Pool may be sold or kept for subsistence purposes. Fish landed during the open periods are allowed to be sold after the period concludes.

24-hour quick reporting required for Washington buyers, pursuant to WAC 220-69-240 except that landings must be reported within 24-hours of completing the fish ticket.
