

#### **POSITION DESCRIPTION and VACANCY ANNOUNCEMENT**

<b>POSITION TITLE:</b>	Entry-Level Wildland Firefighter/Firefighter Type 2 (up to 6 positions)
SALARY:	\$20.00 per hour \$30.00 Over Time (OT) per hour when OT authorized Hazard Pay at 25% increase of base wage when authorized
<b>DEPARTMENT:</b>	Bureau of Indian Affairs (BIA)
LOCATION:	Mission, Oregon
EMPLOYMENT STATUS:	Seasonal (3-6 months) <i>Employment period will be no longer than 6</i> <i>months (1548) hours. #### CTUIR MISSION STATEMENT

Exercise the Tribe's sovereign authority to achieve the maximum protection of resources identified in the Treaty of 1855; to protect newly acquired lands wherein the Tribe has a vested interest, to protect the lands of all the citizens and residents of the Umatilla Indian Reservation. This position will protect human life, water, land, air, and wildlife by exercising professional skills and abilities in the protection of the resources of the Confederated Tribes of the Umatilla Indian Reservation.

#### GENERAL STATEMENT OF DUTIES

Individual will be a member of the fire/fuels crew assigned to conduct fuels reduction treatments and suppress the full range of wildland fires as required, while following safety rules and regulations. Government housing may be available.

### EXAMPLES OF ESSENTIAL JOB DUTIES & RESPONSIBILITIES

- Serve as a member of a fire/fuels crew conducting fuels reduction work and prescribed burn site preparation.
- Works as a wildland firefighter to suppress and manage the full range of wildland fires.
- As a crew member, may perform project work such as road and trail maintenance, habitat manipulation, and miscellaneous equipment and facilities maintenance. Use of hand tools and chainsaws are required.
- May assist higher level workers in forestry research efforts; in the marketing of forest resources; or in the scientific management, protection, and development of forest resources.
- Constructs fire lines, uses pumps and hose lays utilizing appropriate nozzles and nozzle adjustments for the effective use of water and additives.
- Works on, in, and around fire engines, UTVs, and other fire apparatus.
- Follows safety rules and regulations.
- Participate in fire and safety training in the techniques, practices, and methods of fire suppression.
- Performs wildland fire related duties such as fire prevention, patrol, detection and/or prescribed burning.

### WORK CONDITIONS:

The work is primarily performed in forest and desert environments in steep, rugged terrain where surfaces may be extremely uneven, rocky, covered with thick tangled vegetation, etc. Temperatures commonly exceed 100 degrees F and fall below freezing. Risks include smoke inhalation, fire entrapment, snake or insect bites and stings, exposure to excessive machinery noise, and falling and rolling material. Personnel must adjust and cope with exposure to weather elements dust and smoke, poor bivouac and eating situations under an unpredictable set of circumstances. Incumbent may be required to live in backcountry camps for extended periods of time. The hazardous nature of the work requires that personal protective equipment be worn (boots, hard hats, gloves, flame resistant clothing, etc.). Work may require travel by light fixed-wing or rotor-wing aircraft. Employee may be required to be gone as long as twenty-one (21) days in support of wildland fire operations in other parts of the United States.

# **REQUIRED MINIMUM QUALIFICATIONS:** (<u>It is the responsibility of the applicant to demonstrate in</u> writing he/she does meet the following minimum qualifications.)

- 1. U.S. Citizenship is required.
- 2. Must be 18 years of age at the time of hire.
- 3. Demonstrated experience in any type of work that demonstrates the applicant's ability to perform the work of the position, or NWCG certified as a Firefighter Type 2.
- 4. Demonstrated experience that provided a familiarity with the subject matter or processes of the broad subject area of the occupation.
- 5. Boots are a condition of firefighting employment and are purchased by the employee prior to employment. Personnel assigned to wildland fires must wear a minimum of 8-inch high, lace-up exterior leather work boots with Vibram-type melt resistant soles. The 8-inch height requirement is measured from the bottom of the heel to the top of the boot.
- 6. National Wildfire Coordinating Group (NWCG) qualified as a Fire Fighter Type 2 (FFT2)-OR- willing to attend and complete Basic Wildland Firefighter Training.

- 7. National Wildfire Coordinating Group (NWCG) qualified as a Basic Faller (FAL3)-or-willing to attend and complete S-212, Wildland Fire Chain Saws Training.
- 8. Must be able to complete physical test (Incumbent must be able to pass a physical fitness test that consists of walking three (3) miles on level terrain with a 45-pound pack in 45 minutes or less) and show current medical examination.
- 9. A valid driver's license is preferred but not required for this position; preference will be given to candidates who have a valid driver's license and can meet Tribal Insurance Requirements.

#### PHYSICAL DEMANDS:

Duties involve rigorous fieldwork requiring above average physical performance, endurance and superior conditioning. Work requires prolonged standing, walking over uneven ground, and recurring bending, reaching, lifting and carrying of items weighing over 50 pounds and shared lifting and carrying of heavier items, and similar strenuous activities requiring at least average agility and dexterity. Duties include demands for strenuous activities in emergencies under adverse environmental conditions and over extended periods of time. Operation of some specialized fire equipment can place extended physical stress on incumbent during fire activities.

Pursuant to Tribal Worker's Benefit Code, Section 4.02.A. "All workers shall disclose any pre-existing physical or mental disorder and/or disability that could potentially affect or impair the worker's ability to perform in a reasonable and safe manner the activities involved in the position in which they work. Disclosure shall be made in the employment application or interview before commencing employment or before commencing new job duties after job reclassification, reassignment, promotion, demotion, or other change in job duties. The content of such disclosure shall be made promptly by the covered worker after submitting a claim for benefits under this Code."

#### SELECTION PROCESS:

Tribal Personnel Policies Manual, Section 3.01: Employment Preferences

The Tribe's employment preferences shall be as follows:

1. Indian Preference. It shall be the policy of the Tribe to provide preference in hiring opportunities within the Tribal government to CTUIR members and to other Indians enrolled in federally recognized tribes. This CTUIR member and Indian preference shall be applicable in all employees hiring, promotion, and transfer decisions.

2. Veteran's Preference. It shall be the policy of the Tribe to provide preference in hiring opportunities to veterans honorably discharged from the United States Armed Forces.

3. The employment preferences set forth in this section shall apply to all Tribal programs regardless of the program's funding source and shall apply to all classes of positions referenced in section 3.05.

4. Except for the employment preferences authorized under this section, it shall be the policy of the Tribe that no employee or job applicant shall be discriminated against in pursuit of employment or career growth due to race, color, religion, gender, sexual orientation, age or national origin.

All CTUIR Tribal positions are competitive. All employment applications and supportive employment material will be evaluated based on the relevance of the applicant's qualifications and experience as it applies to this

position. Applicants who demonstrate that they meet the minimum qualifications and experience most relevant to this position will be considered qualified to compete for this position and be eligible for an interview.

Applicants who demonstrate that they exceed the minimum qualifications, and experience will be given priority in the hiring process. The applicant can prove they exceed the minimum qualifications by providing documentation of National Wildfire Coordinating Group (NWCG) training certificates, Incident Qualifications and Certification Master Record and/or NWCG Task Book and/or Incident Qualification System with the hiring packet.

#### DRUG FREE WORKPLACE:

The Confederated Tribes of the Umatilla Indian Reservation has a "Drug Free Workplace Policy" and will conduct Pre-Employment Drug Testing. A pre-employment drug test is required before any employment offer is to be made. All tribal employees classified as safety sensitive are subject to random Alcohol and Drug testing pursuant to the Tribal Personnel Policies and Procedures Manual.

#### APPLICATION DEADLINE:

Complete Tribal employment applications will be accepted until at 4:00 P.M., on the posted closing date as found on Page 1 of this announcement or postmarked by that date. ONLY THOSE TRIBAL EMPLOYMENT APPLICATION PACKETS WHICH ARE COMPLETE, WITH ALL ADDITIONAL REQUIRED INFORMATION, AS FOUND IN THE "REQUIRED EMPLOYMENT APPLICATION PACKET MATERIAL" BELOW WILL BE CONSIDERED. Employment application packets received after the application deadline will not be considered.

## It is the responsibility of the applicant to provide sufficient evidence to show they fully meet the qualification requirements.

#### **REQUIRED EMPLOYMENT APPLICATION PACKET MATERIAL:**

- 1. Completed Tribal Employment application.
- 2. Cover letter explaining your qualifications and experience relevant to the functions of this position.
- 3. Personal resume identifying your qualifications and experiences relevant to the functions of this position.
- 4. Completed CTUIR's Supplemental Application Form (both sections, if applicable)
- 5. High School Diploma/GED or copy of official college transcripts (if applicable).
- 6. Tribal and Indian preference: Must provide copy of Tribal Enrollment Card, Certificate of Indian Blood or such with Federally Recognized Tribe.
- 7. Veteran's preference: Must provide proof of honorable service and discharge or completed Form DD214.
- 8. If applicant is Fire Fighter Type 2/Basic Chain Saw Operator qualified, a copy of their Incident Qualification Card must be provided.

#### APPLICANT RESPONSIBILITY

It is the absolute responsibility of the applicant to provide sufficient evidence to show they fully meet the minimum qualification requirements. Applicants failing to meet the minimum qualifications are not granted interviews. If it is questionable as to whether an applicant meets the minimum qualifications, an interview may be granted solely to make that determination.
